- 7. The payment of the EMD by any of the above modes has to be invariably made on or before the bid opening date & time as mentioned in the Critical Date Sheet.
- 8. The documents to be submitted in their bid may be scanned with 100 dpi with black and white option which helps in fast uploading.
- 9. Bidders need not come at the time of Technical as well as Financial Bid opening at ICMR-RMRC N.E.R. They can view live bid opening after logging in on CPPP e-procurement portal at their remote end. If bidder wants to join bid opening at ICMR-RMRC N.E.R, then they have to come with bid acknowledgment slip that is generated after successful submission of online bid.
