Quotations are invited from firms/companies for providing Consultancy Services for on-site Device Fabrication

Scope of Work:

The selected firm will be required to provide on-site consultancy support in the design, development, and fabrication of biomedical/diagnostic devices at the laboratories of ICMR-RMRCNE, Dibrugarh initially for a period of 3 months. The scope includes:

- Providing expertise in electronics system design and integration.
- Assisting in selection, procurement, and integration of sensors, microcontrollers (e.g., Arduino/Raspberry Pi), and other electronic components.
- PCB design, prototyping, and troubleshooting.
- Guidance in fabrication of device enclosures, assembly, and optimization for point-of-care use.
- Ensuring compliance with relevant safety and quality standards.
- Supporting pilot testing and validation phases in coordination with the Institute's project team.

Eligibility Criteria:

- Firms must have qualified Electronics Engineers (B. Tech/BE in Electronics only)
 - Engineers must be available to provide consultancy on-site at ICMR-RMRCNE as on when needed.
- Firms based in Assam or North-Eastern states will be given preference due to the need for on-site consultancy.
