2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 6. **Buyer Added Bid Specific ATC**

1. The Vendor should be registered in the City of Consignee i.e. Assam & Establishment certificate should be produced as documentary proof. Vehicle should be of Commercial Type as per the requirement. No private vehicle is allowed.

2. The Vehicle should be parked in ICMR-RMRCNE Dibrugarh and Kms will be counted from ICMR-RMRCNE Dibrugarh Office to Office.

3. The Rates are inclusive of all taxes etc.

4. Parking and Toll charges will be paid extra on production of receipts.

5. Vehicles will be used for Airport pickup & drop, Bank, Post Office (Packages), field duties and other official purposes as per the requirements etc.

6. No night charges will be paid for night duties.

7. The drivers of the vehicles must possess a valid commercial driver license and must have a minimum 5 years of driving experience.

8. No. of Vehicle required: 05 Nos. (Mahindra Scorpio / Mahindra Bolero) The usage variant shall be 2500 km and 320 hours per month.

9. The contract will initially be valid for one year. Based on the satisfactory performance of the firm, the contract may be extended for further period of two years, in the same rates and subject to satisfactory performance.

11. The rate of each vehicle should be quoted for 2500 km and 320 hours per month. **No daily limit.**

12. Vehicle will be hired on 24 X 7 basis.

13. Fuel of vehicle will be Petrol/ CNG/ Electrical.

14. No additional charges will be paid for Air Conditioner.

15. The Driver need to come in uniform with ID cards issued by the agency.

16. The driver in no case shall report to duty in an inebriated state or consume alcohol while on duty. In such an event user department shall have full rights to terminate the contract with immediate effect.

17. Driver must be provided a working mobile phone and contact number be provided to user department

18. GST Registration Certificate and PAN copies should be uploaded.

19. PAYMENT TERMS 19.1 Payment Condition: (a) The cost of services quoted by the Service Provider shall be cover all aspects of service delivery and include all the components of Fuel, salary/ wages (minimum wage, insurance, PF, ESI, etc) Service charges, GST etc., as applicable. (b) The Payment shall be made as per the financial quotes submitted by the Service Provider and accepted by the Buyer. 19.2 Payment Process : (a) Payment shall be made only after Submission of bill in duplicate along with duty slip and log book, no

20. In case two or more than two agencies quote the price, L-1 will be decided on experience of the agency i.e. the agency which has maximum years of experience shall be considered as L-1 in circumstances. 21. In case two or more agencies quote the price and having same years of experience the L-1 will be decided on turnover of the agency in the field of providing relevant services in last three financial years. Hence, bidder is requested to submit the overall along with the turnover in the field of providing relevant services in last three financial years.

22. In case of any breakdown of the vehicle, the owner has to arrange a substitute vehicle within one hour. Similarly, in the event of non-availability of driver due to sickness or any reason substitute driver will be provided for the vehicle immediately otherwise penalty will be levied. In the event of not providing vehicle, a similar vehicle may be hired from the market and expenditure for the same shall be deducted from the payable amount to vendor.

23. Decision taken by the Director, ICMR-RMRCNE Dibrugarh, at any point of time relating to this process of tender shall be final and conclusive.

24. Conditions mentioned in the Additional Qualification/ Data Required shall prevail over Bid Details.

25. Terms and conditions acceptance letter should be submitted.

26 The vehicles shall be required for the local trip however in case of requirement outside the periphery of local trip. The same shall be apprised in case of emergency purpose and will be notified by the Concerned In-charge.

27 Please note that the local trip includes Dibrugarh, Tinsukia and adjoining places like Dhemaji, Shivasagar, Charaideo etc. Since the trip can be covered within one day.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
